### Notice convening a special meeting of Members and Creditors of AfrAsia Bank Zimbabwe Limited (In Liquidation) - CR 27/15

#### Hereinafter referred to as “AfrAsia”

#### Special meeting of Members and Creditors

Notice is hereby given that a special meeting of members and creditors will be held at 8.30am on Thursday the 18<sup>th</sup> of February 2016, at the Rainbow Towers Hotel, 1 Pennefather Avenue, Samora Machel Avenue West, Harare.

#### Purpose of the meeting

#### Proof of Claims

If you are owed money by AfrAsia and have not yet lodged in your claims with the Master of the High Court, please complete and submit the attached Proof of Claim Forms. You will be required to complete these forms in triplicate and lodge them with the Master of High Court, at the Master’s office, Corner Second Street & Herbert Chitepo, Harare, at least 48 hours before the meeting. In other words, your claim forms must be lodged with the Master of the High Court, by **Tuesday, the 16<sup>th</sup> of February 2016 before 8.30am** for the meeting scheduled for **Thursday, the 18<sup>th</sup> of February 2016 at 8.30am**.

A representative of your organisation, duly appointed, should then appear in person before the Master in order to prove your claim on the day of the meeting. If no one is in attendance on the day of the meeting, your claim will be rejected for non-appearance. Those whose claims were ACCEPTED in the first and second creditors’ meetings DO NOT NEED to resubmit their claims and attend this special meeting of creditors.

Creditors are advised to ensure that their documentation is in order, i.e. FULL NAME OF THE BANK MUST BE STATED (i.e AFRASIA BANK ZIMBABWE LIMITED – IN LIQUIDATION) as the Master of the High Court may reject claims for incorrect documentation. Where the supporting documentation does not exactly correspond to the name of the company, creditors are advised to support their claim with an Affidavit to the effect that their dealings are in fact with the bank under liquidation and the documents relate to those dealings.
