The Bulawayo meeting will be held before the Deputy Master of the High Court at Holiday Inn, 8 Milnerton Drive, Ascot, Bulawayo on Thursday 19 November 2015 at 10.00 am.

Proof of Claims

2. The purpose of the meeting is for submission of proof of claims by creditors and consideration of the Liquidator's report. If you are owed money by Afrasia Bank and you have not lodged your claim with the Master of the High Court, please contact our offices so that you can collect and complete the proof of claim forms. The proof of claim forms are also available via electronic mail upon request and can also be downloaded from our website: www.dpcorp.co.zw

You will be required to complete these forms in triplicate and lodge them with the Master of the High Court, Master House, Herbert Chitepo/Sam Nujoma Street in Harare or the Deputy Master of the High Court, 8th Avenue/Herbert Chitepo Street, Bulawayo, at least 48 hours before the relevant meeting.
4. You in person or a duly appointed representative of your organization should then appear in person before the Master of the High Court Harare at Rainbow Towers on 18 November 2015 or the Deputy Master of the High Court Bulawayo at Holiday Inn, Bulawayo on 19 November 2015 in order to prove your claim. If you, or your representative are not in attendance on the day of the meeting, your claim will be rejected for non-appearance.
5. If your claim was provisionally accepted at the first meeting, you are **not required** to submit another set of forms **but you are encouraged** to attend the forthcoming meeting for the purpose of receiving the Liquidator's update.
