The Bulawayo meeting will be held before the Deputy Master of the High Court at Bulawayo Rainbow Hotel on Friday 25 September 2015 at 11.00 am.
2. **Proof of Claims**
The purpose of the meeting is submission of further proof of claims by creditors and consideration of the Provisional Judicial Manager's report. If you are owed money by Tetrad Investment Bank Limited and you have not lodged your claim with the Master of the High Court, please contact our offices so that you can collect and complete the proof of claim forms. You will be required to complete these forms in triplicate and lodge them with the Master of the High Court, Master House, Herbert Chitepo/Sam Nujoma Street in Harare or the Deputy Master of the High Court, 8th Avenue/Herbert Chitepo Street, Bulawayo, at least 48 hours before the relevant meeting.

You in person or a duly appointed representative of your organization should then appear in person before the Master of the High Court Harare at Rainbow Towers on 24 September 2015 or Deputy Master of High Court Bulawayo at Bulawayo Rainbow Hotel on 25 September 2015 in order to prove your claim. If you, or your representative are not in attendance on the day of the meeting, your claim will be rejected for non-appearance.
5. If your claim was provisionally accepted at the first meeting, you are **not required** to submit another set of forms **but you are encouraged** to attend the forthcoming meeting.
